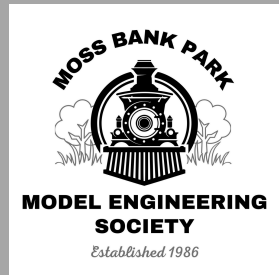

Moss Bank Park Model Engineering Society Privacy Notice

1. Introduction:

Moss Bank Park Model Engineering Society is committed to protecting your personal information and complies with the UK General Data Protection Regulation (GDPR).

This Privacy Notice explains how we collect, use, and store your personal data.

2. Information We Collect:

- Name
- Contact details (email, phone number, address)
- Membership details (join date, membership type)
- Payment information (if applicable)
- Any other data provided voluntarily during club activities or registration

3. How We Use Your Information:

To manage memberships and process expenses payments

To communicate important club updates, events, and information

To organize club activities, including the operation of the miniature railway

To organise competitions and give aways as part of the promotion of the miniature railway

To organise events and fundraising activities as part of the miniature railway

To address any safety concerns or incidents

4. Legal Basis for Processing Data:

Consent:

For specific activities where explicit consent is required (e.g., sharing phone contact details with other members as part of our phone call communication sheet)

To update supporters who have requested to be kept up to date with marketing information about upcoming events.

Legitimate Interest:

To manage club operations, maintain member communication, and deliver club services

To safely manage the operation of the miniature railway and safeguarding of members and visitors.

5. Data Storage and Retention:

We will only store your personal data for as long as necessary to fulfil the purposes outlined above.

Membership data is held for the duration of membership and an additional 12 calendar months after a membership ends to support any safety or incident reviews.

Marketing data will be held until the person opts out of marketing or the club ceases to operate the miniature railway.

Once no longer required, data will be securely deleted and paper records shredded.

6. Your Data Protection Rights:

Right to Access:

You have the right to request a copy of your personal data held by the club at anytime by contacting the Membership Secretary in writing.

Right to Rectification:

You can request to correct any inaccurate information

Right to Erasure:

You can request to have your personal data deleted in certain circumstances

Right to Restriction:

You can request to restrict the processing of your data in certain situations

Right to Object:

You can object to the processing of your personal data for direct marketing purposes. You can opt out of our event marketing at any time by following the instructions at the bottom of our marketing emails.
